SUBJECT: NOTICE CALLING FOR THE GENERAL MEETING 8 MAY 2021

Dear Presidents/Chairpersons and General Secretaries

The SASCOC Constitution provides as follows: -

Clause 14.1 SASCOC shall hold at least 2 (two) General Meetings of Members during a financial year, of which one shall be the Annual or Quadrennial General Meeting to be held not later than 9 (nine) months after the end of each financial year.

Clause 15.1 A meeting called for the passing of a special resolution shall be called by not less than 21 (twenty-one) clear days' notice in writing and any other General Meeting (other than the Annual General meeting) shall be called by not less than 14 (fourteen) clear days' notice in writing. Notice in terms of this Article shall be exclusive of the date on which it is served or deemed to be served and exclusive of the date for which it is given.
